- 4) Riding a Jumper medal course and flat phase and what the judge is looking for
- 5) Riding a Jumper course
- 6) Riding a Jump off

Participate in a Hunter Under Saddle Class and an Equitation on the Flat Class (during Expo)

Saturday, February 13:

Participate in a session on Conformation and how it affects jumping style and soundness (during Expo)
